Terms and Conditions

Registration: If you have not attended the DGKN Basics Courses, please send a short letter of interest along with a list/prove of previous courses/experience in the context of perioperative and intraoperative mapping and neuromonitoring and the registration form to the head office of the German Society of Clinical Neurophysiology and Functional Neuroimaging (DGKN).

The acceptance of your registration will depend on the total number of applicants (maximum attendees: 30) and your personal level of expertise. Upon successful review of your application, registration will be confirmed and the invoice will be issued.

E-learning and Mandatory Content: International and external participants who have not been part of the DGKN (Basics) curriculum so far, will be provided with on-demand e-learning material approximately 6-8 weeks prior to the course. Participants who have completed the basic courses will gain access to the e-learning material likewise to repeat contents ahead of the summer school. Part of the introductory lectures specific to the hands-on training topics will be available online only. Please make sure to watch them prior to the course. These contents will not be repeated. The access data may not be passed on to third parties. The material is available exclusively for the personal use of the participant and must be kept inaccessible to third parties.

Participation Fees: include the bus transfer from/to Lisbon Airport as well as the costs for accommodation (in double occupancy of twin-bedded rooms! Single rooms at extra costs upon request) and full catering (incl. drinks flat rate; excl. high-proof spirits and cocktails). In case of external accommodation (self-organized), a discount of 100 EUR will be applied. The travel (from home) to and from Lisbon airport must be organized independently and is not included in the fee.

The **passive participation fee** (e.g. for industry staff) is 350 EUR and includes full catering (but not accommodation). External dinner participation (e.g. of family members) is generally possible upon request and payment.

Networking Events: The participation in the paid networking events is voluntary. The additional fee needs to be paid on-site directly to the course administration team and will be announced in the final programme.

Video and Photos: Please note that videos and photographs may be taken during the summer school. By signing the registration you grant permission to the DGKN to use any visual material in which you might be seen or heard for purposes of press and public relations. Data will be held for the whole duration of the project (max. 10 years), in both printed and digital form, for the purpose of disseminating information on the project's activities via various channels and in compliance with the GDPR. You can object to the processing of photos and videos at any time for future use, in case you are clearly exposed, at any time in writing. Please send your objection to assistenz@dgkn.de.

Cancellation of the Summer School is possible up to and including January 15, 2026, with a full refund of the booking amount. After this date, the full fee is due. In the event of cancellation after this deadline, e.g., due to illness, cancellation free of charge is only possible upon immediate presentation of a medical certificate. If proof cannot be given, registration fee will be fully charged.
